#### Directions to Sidney American Legion

From I-88 - take Exit 9 - go north on Route 8 until first light - turn right onto Delaware Street. Turn left onto Union Street at the first stop sign. The Legion is on the left just past the railroad tracks next to a car dealership.  
From Route 8 - if coming from the south follow directions above or if coming from the north - turn left onto River Street (the street that the Fireman's Field is on). Union Street is just past the Fire Department - turn right onto Union Street. The Legion is on the right just past the car dealership.
